This product has been designed for consumers whose likely objectives, financial situation and needs (as listed below) are aligned with the product (including the key attributes). This product is for our members who:

- Are at the Tasmania Rokeby Academy, or at session 2 of the NSW Goulburn Academy, or have graduated from either Academy within the last 6 months and who are looking to obtain funds for the purchase of a new or used car, household goods, debt consolidation or education expenses.

#### Product description and key attributes

The key eligibility requirements are:

- An existing or becoming a member of Police Bank
- At the Tasmania Rokeby Academy, or at session 2 of the NSW Goulburn Academy, or have graduated from either Academy within the last 6 months
- 18 years or age or over
- Be living in Australia as an Australian citizen, permanent resident, or New Zealand citizen who holds a Special Category Visa (SCV).
- Demonstrated ability to repay the loan as per the Bank's Credit criteria.

The key product attributes are:

- Minimum loan amount \$5,000
- Maximum loan amount is \$20,000 unsecured and \$60,000 secured
- Minimum loan term is 12 months
- Maximum loan term is 7 years
- No monthly or annual account keeping fee
- Unlimited additional repayments
- Repayment frequency is monthly, fortnightly, or weekly
- Application fee waived
- Fixed and Variable rates options available for unsecured lending. For new car purposes, Fixed rates only available.
- Principal and Interest repayments only
- No interest and no repayments for the first 3 months.

- Do not meet the Bank's Credit eligibility criteria at time of application
- Are looking to borrow less than \$5,000
- Are looking to borrow more than \$20,000 unsecured or \$60,000 secured lending
- Are looking to access redraw
- For purposes other than new or used car, household goods, debt consolidation or education expenses.

### Distribution conditions
